PAN-AFRICAN COUNCIL LETTER OF ENDORSEMENNT OF THE 6TH REGION AU-ECOSOCC ELECTIONS

Union and its related organs, in order to be effective Members of AU-ECOSOCC ensuring that they serve and represent the 6th Region effectively.

• **Regional Collaboration**: The methodology fosters strong regional collaboration, helping to unify the African Diaspora around shared goals and objectives.

We are confident that this process shall lead to the selection of qualified and committed individuals who will effectively represent the interests of the African Diaspora and contribute positively to the work of AU-ECOSOCC.

We fully support this initiative and are happy to participate within a team of regional leaders for the Americas and/or support in any of the other regions where we have representation who may be in a position to help to facilitate this process.
